Processing of personal information



In connection with your use of Lundbeck's Contribution Portal, the Lundbeck Group ("Lundbeck" or "we") will (as the data controller) collect, process, use and disclose personal data about you as described in more detail in this Privacy Statement.

Lundbeck will process your personal data according to applicable legislation, including the EU General Data Protection Regulation ("GDPR").

What categories of personal data are we processing and for what purposes?

We collect and process the following types of personal data about you:

- Name
- Preferred salutation
- Degree(s)
- Contact information (email, mail, delivery address, telephone)
- Primary organization
- Curriculum Vitae (CV)
- Unique identifier

We process your personal data for the following purpose:

- to provide access to a specific part of our website
- to contact you regarding the services you have requested
- to provide the services you have requested, such as email notifications and orders
- to carry out surveys about how to improve our service to you
- for other purposes directly requested by you
- to enforce an agreement between you and Lundbeck
- to enable our defense in legal processes (i.e. in relation to civil and criminal subpoenas, court orders, other mandatory disclosures, etc.)
- to comply with national laws and/or pharmaceutical industry standards requiring Lundbeck to
 - o accommodate inspections by national or regional health authorities
 - o publicly disclose transfers of value made to or for the benefit of an individual healthcare professional, healthcare organisations, patient organisations, etc.
- to respond to service inquiries
- to protect the rights or property of Lundbeck or the personal safety of the users of this website

What is the legal basis for our processing of your personal data?

The legal basis for our collection and processing of your personal data set out above is:

• GDPR Article 6 (1) (f) ("the balancing of interest test"). It is Lundbeck's assessment that the processing of your personal data is necessary to enable us to potentially offering contributions such as support for independent research initiatives and educational grants.



Will we disclose your personal data to third parties?

In connection with national or regional health authorities' inspection of Lundbeck, your personal data may be disclosed if required by law.

Will we disclose your personal data to data processors?

We transfer your personal data to our Lundbeck Contribution Portal vendor, which will process your personal data on our behalf and on our instructions.

Will we transfer your personal data to recipients in countries outside the EU/EEA?

We may transfer your personal data to health authorities located in countries outside the EU/EEA as required by law for important reasons of public interest in accordance with GDPR Article 49 (1) (d).

Moreover, we may transfer your personal data within Lundbeck. Such transfer will be subject to our Binding Corporate Rules, cf. GDPR Article 47.

How long will we store your personal data?

We store your personal data for as long as necessary to fulfil the purposes described above, however, for no longer than seven (7) years beyond the period for ongoing activities between you and Lundbeck.
